I understand and acknowledge that riding all-terrain vehicles, trucks, cars, and racing machines of any kind, being in the outdoors, and participating in any and all other activities of any kind, that might be engaged in as a participant or spectator bears certain risks and unanticipated risks which could result in injury, death, illness or disease (both physical and mental), or damage to myself, my property or to spectators or other third parties. Being aware of the risks stated above:

- I expressly agree to accept and assume all responsibility for injury, death, illness or damage to myself, to others or to mine or a third parties personal property arising from my participation in this activity/event of racing, riding or any other activity at the Dirty Chicks ATV Ride.
- I acknowledge that my participation in any activity is purely voluntary, no one is forcing me to participate and I independently elect to participate in spite of the risks. I further acknowledge that Townsquare Media, LLC and its affiliates at Dirty Chicks ATV Ride make no express or implied representation as to the condition of any roads, buildings, trails, gates or other improvements where Dirty Chicks ATV Ride will take place. I further understand that I may be exposed to other dangerous conditions, risks and hazards at Dirty Chicks ATV Ride, including, but not limited to, wild animals, insects, trees, water, other people, erosion and general conditions of the land both on and off roadways and trails, which may create hazardous driving, riding and walking conditions for both my person and my property.
- I expressly acknowledge the existence of all such risks, hazards and dangers which I may be exposed to on Dirty Chicks ATV Ride and assume all responsibility for injury, death, illness, or damage to myself, to others or to my personal property arising from my presence on Dirty Chicks ATV Ride.
- Further, in exchange for right to enter Dirty Chicks ATV Ride and engage in the activities described above, I hereby voluntary release, forever discharge and agree to hold harmless and indemnify Dirty Chicks ATV Ride, its agents or employees, owners, and all associated persons or entities from any and all liability, claims, demands, actions or rights of all actions, which are related to, arise out of, or are in any way connected with my participation in activity offered during the event, including specifically but not limited to the negligent acts or omissions of Dirty Chicks ATV Ride, its agents or employees, volunteers, owners, and all other associated persons or entities for any and all injury, death, illness or disease, and danger to myself or to my property.
- In signing this document, I expressly acknowledge that I am releasing Townsquare Media, LLC and its affiliates at Dirty Chicks ATV Ride and its officers, directors, agents, representatives, employees, sponsors, and volunteers from liability for damages caused by any negligence or omissions on behalf of Dirty Chicks ATV Ride and its officers, directors, agents, representatives, sponsors and volunteers.

- I understand that by agreeing to indemnify Dirty Chicks ATV Ride should it become necessary for Dirty Chicks ATV Ride, or someone on Dirty Chicks ATV Ride's behalf, to incur attorneys' fees and costs to enforce this agreement, or any portion thereof, I agree to pay Dirty Chicks ATV Ride reasonable attorneys' fees and costs arising there from. The release, discharge, and indemnification voluntarily given herein shall extend to, and for the benefit of, any corporation, partnership, or other entity affiliated with any of the following: Dirty Chicks ATV Ride, its operations or property, including but not limited to partners, landowners, volunteers, sponsors, or limited partners. I certify that I have sufficient health, accident, and liability insurance sufficient to cover any bodily injury or property damage that I may incur while participating in this event. I further covenant to cover any bodily injury or property damage caused to a third party as a result of my participation in the activities described above. If I have no insurance, I certify that I am capable of personally paying for any and all such expenses or liability. If any provision of this Participant Release and Indemnification Agreement is or may be held by a court of competent jurisdiction to be invalid, void, or union force-able, the remaining provisions shall nevertheless survive and continue in full force and effect without being impaired or invalidated in any way. Should any dispute arise under the terms of agreement, the parties agree that the venue for dispute of the resolution, albeit it by litigation or dispute resolution shall be identified by city and state that will be most convenient for the parties involved.
- SIGNATURE OF PARENT/GUARDIAN IS REQUIRED FOR ALL MINORS UNDER THE AGE OF 18. I have read, understood, and accept the terms and covenants contained herein.
